## 4. Tuition Remission/Reimbursement

Check with your school division's Human Resources office about tuition remission or reimbursement. Many divisions offer up to \$500 per course, making the courses just \$100 out-of-pocket for teachers.

## 5. Career Switcher Program

If you are a recently provisionally licensed teacher, you may be eligible for our VDOE-approved alternative route to licensure [M.Ed. Career Switcher Program](#). The low cost of the Career Switcher Program is comparable to the non-degree Professional Development course rate. Financial aid is available to cover the Master's degree program. ## 6. Master's Degrees

Did you know that many school divisions provide allowances toward teacher salaries once a master's degree is earned? Regent University offers a [Master of Education \(M.Ed\)](#) for teachers that allows teachers to take non-degree, low-cost credits and put them toward the M.Ed. The M.Ed. is a 30-credit hour degree. After completing 18-21 credit hours at the non-degree Professional Development rate, approximately 9-12 more credits (3-4 courses) are taken at the regular course rate. With school division allowances, the M.Ed. could be paid off quickly!

### Sample Cost

30-credit master's degree

18 credits at the \$200 per credit hour rate is \$3600

12 credits at the master's rate with university fees\*\*

You could earn an M.Ed. for around \$7000 compared to upwards of \$50,000 for the average\*\*\* M.Ed. Depending on your division's tuition remission and master's allowance, you may be responsible for even less!
