Job Title: Locksmith

Job Summary

Position is responsible for ensuring the proper operation of all locks in the school division's buildings. Responsible for opening, installing and re-keying locks.

Essential Duties

1. Repairs and re-keys locks.
2. Picks locks when keys are missing.
3. Completes work orders.
4. Establish and maintain keying system database for each facility.
5. Models nondiscriminatory practices in all activities.

Other Duties

1. Performs any other related duties as assigned by the Shop Supervisor or other appropriate administrator.

Job Specifications

Minimum Qualifications (Knowledge, Skills and/or Abilities Required)

Completion of standard high school or G.E.D. certificate or specialized training as a Locksmith. Must have at least six (6) months experience or attend and complete locksmith training within six months of hire date. Ability to work with others. Able to stoop, crawl and kneel.

Working Conditions and Physical Requirements

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform essential functions.

Must have the ability to stand for extended periods of time; exhibit manual dexterity to operate equipment; see and read printed material with or without vision aids; hear and understand speech at normal levels; speak in audible tones so that others may understand clearly in person and on the telephone; ability to understand and follow oral and written instructions; physical agility to lift 50 pounds; to bend, stoop and reach overhead.

Work Environment

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions. Duties are normally performed inside and outside in a workshop/building environment. The noise level in the work environment is sometimes loud but usually moderate.
